- **ARTICLE 4-4.4.2**
- **THE FOLLOWING ARE PERMITTED:**
 - SHOULDER, UPPER ARM, THIGH OR LOWER LEG PROTECTIVE EQUIPMENT IF SUFFICIENTLY PADDED
 - ARM AND LEG COMPRESSION GARMENTS
- ALL PLAYERS ON THE TEAM MUST HAVE ALL OF THEIR ARM AND LEG COMPRESSION GARMENTS, HEADGEAR, WRISTBANDS,
 HEADBANDS AND TAPING OF THE SAME SOLID COLOUR.



- **ARTICLE 4-4.4.2**
- ONLY GARMENTS THAT ARE COMPRESSION CAN BE WORN BELOW THE UNIFORM. COMPRESSION MEANS SKIN TIGHT INCLUDING SLEEVES AND LEG WEAR
- THEY SHOULD ALL BE THE SAME COLOUR AND SAME COLOUR
 ACROSS THE TEAM



- 38 Team Uniforms
- 38.1 Team uniforms must comply with the official rules of basketball (as updated and defined by FIBA) http://www.fiba.basketball/documents
- 38.3 All Division One Men and Women must follow FIBA rules on permitted uniform and equipment.
- 38.4 All Division Two Men and below, Division Two Women and all junior leagues are permitted uniform/equipment contrary to the FIBA rules as follows:
- 38.4.1 Socks do not have to be the same dominant colour for all team members but do need to be visible.
- 38.4.2 All players on the team who wear arm and leg compression sleeves, headgear, wristbands and headbands and tapings, do not need to be the same solid colour.
- 38.4.3 Any other equipment not specifically mentioned in this article must be approved by Basketball England.



- THIS RULE OF COMPRESSION RULES ETC WILL APPLY TO THE BBL AND WBBL.
- IT IS THE REFEREES ROLE TO ENFORCE THIS FROM 20 MINUTES BEFORE, JUMP BALL AND FOLLOWING SUBSTITUTIONS.





END OF PLAYING TIME ART 8, 10, 34


A FOUL COMMITTED AT THE END OF A QUARTER WHERE FREE THROWS ARE TO BE TAKEN MUST HAVE TIME REMAINING ON THE CLOCK IF THE FOUL WAS COMMITTED IN TIME.

IF THE FOUL IS IN TIME THERE CANNOT BE 00:00:00 ON THE CLOCK AND NO LINE UP FOR ANY RESULTING FREE THROWS. THE OFFICIALS MUST PUT AT LEAST 00.00.1 SECONDS ONTO THE CLOCK

THIS BEING THE CASE THERE SHOULD BE NO SITUATIONS WHERE FREE THROWS ARE TAKEN WITH NO LINE UPS.



END OF PLAYING TIME







BENCH AREA- ART 9

TEAMS GENERALLY WARM UP IN FRONT OF THEIR OWN BENCHES AT THE START OF THE GAME.

IF TEAMS PLAY DEFENCE IN FRONT OF THEIR OWN BENCH IN THE 3RD AND 4TH QUARTER. WHEN THE OPPOSING TEAM SCORES THE TABLE OFFICIALS ARE FACING THE TEAM BENCH AND HAVE BETTER OPPORTUNITY TO RECOGNISE ANY TIME OUT REQUEST FROM THE COACH AND RESPOND PROMPTLY.

BENCH AREA- ART 9

Art. 9 Beginning and end of a quarter, overtime or the game

- 9.4 For all games, the first team named in the schedule (home team) shall have, when facing the court from the scorer's table:
 - its team bench on the left side of the scorer's table,
 - its warm-up before the game in the half-court in front of its team bench.

However, if both teams agree, they may exchange the team benches and/or warm-up half-courts for the first half.



JUMP BALL~ ALT POSSESSION ART 12

IF AT THE OPENING JUMP BALL THE BALL IS NOT SECURED BY A TEAM ON THE PLAYING COURT THE FIRST POSSESSION WILL BE DEEMED FOR THE TEAM THAT HAS THE LIVE BALL AT THEIR POSSESSION OUT OF BOUNDS, OOB.

MEANING IF THE JUMP BALL IS KNOCKED STRAIGHT OUT OF PLAY BY TEAM A. ONCE THE BALL IS AT THE DISPOSAL OF TEAM B, OOB, THE POSSESSION ARROW CAN BE SET TO POINT TO TEAM A.



JUMP BALL~ ALT POSSESSION ART 12

12.5.2

THE TEAM THAT DOES NOT GAIN THE FIRST TEAM CONTROL OF A LIVE BALL AFTER THE JUMP BALL SHALL BE ENTITLED TO THE FIRST ALTERNATING POSSESSION THROW-IN





THROW IN FOUL ART 34/37

- TO ENSURE THAT NORMAL BASKETBALL FOULS ARE NOT CALLED UNSPORTSMANLIKE AT THE END OF THE GAME, IN THE LAST 2:00:00 MINUTES, THE C5 FOUL HAS BEEN REMOVED AND REPLACED. THE REFEREE, WHEN THE BALL IS OUT OF BOUNDS AND IN THE HANDS OF THE PASSER IN, CAN CALL A NORMAL FOUL FOR A NORMAL BASKETBALL ACTION.
- THE PENALTY IS 1 FREE THROW AND POSSESSION TO THE TEAM FOULED AT THE POINT WHERE THE INFRACTION OCCURRED. THE SHOT CLOCK SHALL BE ADJUSTED ACCORDINGLY AS TO WHERE THE INFRACTION TOOK PLACE.
- REFEREES CAN STILL CALL A UF FOUL FOR ACTIONS THAT RELATE TO:
 - C1- NO LEGITIMATE ATTEMPT TO PLAY THE BALL WITHIN THE SPIRIT AND INTENT OF THE RULES
 - C2- EXCESSIVE OR UNNECESSARY CONTACT



THROW IN FOUL ART 34/37

ART 34 PERSONAL FOUL

34.1.1 A PERSONAL FOUL IS A PLAYERS ILLEGAL CONTACT WITH AN OPPONENT, WHETHER THE BALL IS LIVE OR DEAD

34.1.2 A THROW-IN FOUL IS A PERSONAL FOUL COMMITTED, WHEN THE GAME CLOCK SHOWS 2:00 MINUTES OR LESS IN THE FOURTH QUARTER AND IN EACH OVERTIME, BY A DEFENSIVE PLAYER ON AN OPPONENT ON THE PLAYING COURT WHEN THE BALL IS OUT-OF-BOUNDS FOR A THROW-INN AND STILL IN THE HANDS OF THE REFEREE OR AT THE DISPOSAL OF THE PLAYER TAKING THE THROW-IN



THROW IN FOUL ART 34/37

PENALTY

- ONE FREE THROW BY THE PLAYER FOULED
- GAME RESUMED BY A THROW IN AT THE PLACE WHERE THE FOUL WAS COMMITTED

RESTART

SHOT CLOCK

- 24 SECONDS IF THE FOUL WAS COMMITTED IN THE BACKCOURT
- THE REMAINING TIME, BUT NEVER LESS THAN 14 SECONDS IF THE FOUL WAS COMMITTED IN THE FRONT COURT





UNSPORTSMANLIKE FOUL ART 37

UNSPORTSMANLIKE FOUL CRITERIA "CLEAR PATH" C4 CLARIFIED

FOUL BEHIND OR LATERALLY-ON A PLAYER PROGRESSING TO THE OPPONENTS BASKET WITHOUT ANY OTHER OPPONENT BETWEEN THEM AND THE BASKET

SCORER & TIMEKEEPER DUTIES ART 48/49

- THE TASK OF NOTIFYING THE FLOOR OFFICIALS WHEN A PLAYER HAS 5 FOULS
 HAS MOVED FROM THE SCORER TO THE TIMEKEEPER.
- WE RECOGNISE THAT WHERE THERE ARE 3 TABLE OFFICIALS OR LESS, THE EXPECTATION AND LOAD OF THE TIMER IN THE GAME, AND ESPECIALLY THE LAST 2 MINUTES IS SUBSTANTIAL. THE ADOPTION OF THIS MECHANIC IN THE 3 TO SITUATION OR LESS, HAS BEEN CONSIDERED AT LENGTH AND THE FOLLOWING WILL BE ADOPTED AND WE WILL MONITOR THIS GOING FORWARD.



SCORER & TIMEKEEPER DUTIES ART 48/49

- TABLE OFFICIAL MECHANICS WILL FOLLOW TOM (ONCE UPDATED) & OBR 2022 V1.0 EXCEPT:
- FOR GAMES OPERATED WITH ONLY 2 OR 3 TABLE OFFICIALS:
 - THE SCORER WILL TAKE RESPONSIBILITY OF EFFECTING SUBSTITUTIONS INSTEAD OF THE TIMER
 - THE SCORER WILL TAKE RESPONSIBILITY OF EFFECTING TIME-OUTS INSTEAD OF THE TIMER
 - THE TIMER WILL CONTINUE TO TAKE RESPONSIBILITY OF RAISING THE PERSONAL FOUL MARKERS
 - THE TIMER WILL CONTINUE TO INFORM A REFEREE WHEN A PLAYER HAS COMMITTED THEIR FIFTH FOUL (RULE CHANGE 2022)



SCORER & TIMEKEEPER DUTIES ART 48/49

- TABLE OFFICIAL MECHANICS WILL FOLLOW TOM (ONCE UPDATED) & OBR 2022 V1.0 EXCEPT:
- FOR GAMES OPERATED WITH 4 TABLE OFFICIALS:
 - THE ASSISTANT SCORER WILL TAKE RESPONSIBILITY OF EFFECTING SUBSTITUTIONS INSTEAD OF THE TIMER*
 - THE ASSISTANT SCORER WILL TAKE RESPONSIBILITY OF EFFECTING TIME-OUTS INSTEAD OF THE TIMER*
 - THE ASSISTANT SCORER WILL TAKE RESPONSIBILITY OF RAISING THE PERSONAL FOUL MARKERS INSTEAD OF THE TIMER*
 - THE ASSISTANT SCORER WILL INFORM A REFEREE WHEN A PLAYER HAS COMMITTED THEIR FIFTH FOUL (RULE CHANGE 2022)*

* IF THE TABLE OFFICIAL CREW DECIDE TO KEEP ONE OR MORE RESPONSIBILITIES WITH THE TIMER DUE TO CONSIDERATIONS SUCH AS THE EQUIPMENT THEY ARE USING, GIVEN THE FLEXIBILITY IN OBR 48.2, THIS IS PERMITTED.





SIGNALS- CYLINDER FOUL

- AS THE CYLINDER FOUL IS DEEMED TO BE A 'SPECIAL'
 ACTION THAT MAY CAUSE CONFUSION WITH THE PLAYERS A
 NEW ILLEGAL SIGNAL HAS BEEN PRODUCED TO HELP
 EXPLAIN THE FOUL
- WE MUST ALWAYS GIVE VERBAL SUPPORT TO ALL OF OUR SIGNALS

A - REFEREES' SIGNALS

ILLEGAL CYLINDER



Both arms with hands vertical moving down and up

SIGNALS- GOAL TENDING & BASKET INTERFERENCE


- THERE IS NO SIGNAL FOR GOAL TENDING AND BASKET
 INTERFERENCE SO THIS HAS BEEN INTRODUCED ACCORDINGLY
- WE MUST ALWAYS GIVE VERBAL SUPPORT TO ALL OF OUR SIGNALS

A - REFEREES' SIGNALS

GOALTENDING /
BASKET INTERFERENCE




Rotate finger, extend index finger over the other hand with a circle



FIBA IOT MANUAL UPDATE- WARNING WHISTLE


- A "WARNING WHISTLE" SHOULD OCCUR:
- PRIOR TO THE CREW CHIEF ENTERING THE CIRCLE FOR THE JUMP BALL AT THE OPENING TOSS
- PRIOR TO THE BALL BEING PLACED AT THE DISPOSAL OF THE THOWER IN AT THE START OF EACH QUARTER
- PRIOR TO THE BALL BEING PLACED AT THE DISPOSAL OF THE THROWER IN AT THE END LINE IN THE FRONT COURT
- PRIOR TO THE BALL BEING PLACED AT THE DISPOSAL OF THE THROWER IN TO RESTART THE GAME AFTER A TIME OUT



FIBA IOT MANUAL UPDATE- 3 POINT SHOT

- CORRECT 3 POINT SHOT MECHANIC
- ONLY THE PRIMARY REFEREE [TRAIL OR CENTRE] SIGNALS THE 3 POINT ATTEMPT
- IN DUAL COVERAGE BOTH CAN SIGNAL
- IF THE BASKET IS MADE, BOTH OUTSIDE REFEREES SIGNAL THE SUCCESSFUL BASKET

3 fingers extended
One arm: Attempt
Both arms: Successful

THERE ARE NOTABLE CHANGES TO THE IRS RULES.


